Conditions of participation

The participation for our prize lottery, Goebel GmbH, Mühlenstr. 2-4, 40699 Erkrath, hereinafter referred to as »organiser« or »operator« is free of charge and shall comply exclusively with these terms and conditions.

Procedure of the competition

The duration of the competition starts at 15.10.2019 - 31.10.2019. During this time participants can participate online at the prize competition.

Participation

To be part of the prize competition you need to send us a filled out E-mail. You can only participate within the period mentioned above. Submissions which are handed in too late are not part of the prize competition.

Per participant only one registration can be submitted to the prize competition. It is strictly prohibited to use multiple E-mail addresses to increase the chances of winning.

The participation for the prize competition is free of charge.

Eligibility

Any natural persons under 18 Years of age can participate. The participation is not limited for non-customers, as well it is not linked to any purchases or service of the operator.

If a participant's legal capacity is limited, the consent of the subject's legally acceptable representative is needed.

Not eligible for the prize competition are persons involved in the conception and realization of the competition, are barred from participation. This applies to the operators employees and their family members. Additionally the operator reserves the right in their sole discretion to disqualify or prevent from participating in the Promotion, any individual it finds to be tampering with the entry. For instance:

(a) manipulation in connection with the access or execution of the prize competition, (b) in the event of a violation of the conditions of participation, (c) unfair competition or (d) any false or misleading information in connection to the prize competition.

Prize, notification and transmission of the win

Furthermore, the user may at any time revoke his/her consent with effect for the future. The revocation is to be announced in writing to the operator. After the revocation, any personal data will be deleted instantly.

Applicable law

Severability clause

Should individual terms of this Agreement be ineffective or lose their effectiveness due to later circumstances or should a loophole emerge in this Agreement, the legal effectiveness of the other provisions is not affected. The invalid contractual provision shall be replaced or the loophole filled by an appropriate provision which comes as close as possible to what the parties to the Agreement would have wanted, had they considered the point.
